

**PROCEEDINGS OF THE RE-TENDERING OPENING COMMITTEE
FOR ALLOTMENT OF 24X7 CANTEEN SERVICES AT CIVIL HOSPITAL PALAMPUR**

In Continuation to the re-tendering process initiated vide no. MS/CH-Plp/RKS-Canteen/2025-26/-1293 dated 16-2-2026 for allotment of 24x7 Canteen Services at Civil Hospital Services at Civil Hospital Palampur. The meeting of the Re-Tender Opening Committee was convened in the office of the Medical Superintendent Civil Hospital Palampur to open and scrutinize the technical bids received from interested bidders.

As per the Tender Schedule notified earlier the Technical Bids were opened on 3-3-2026 in the presence of members of the duly constituted committee and the representatives of the bidders who were present at the time of opening. The Committee ensured that the Tender Opening process was conducted in a transparent and fair manner in accordance with the terms and conditions mentioned in the Tender document.

A total of Six tenders Mentioned below were received within the stipulated time period. All the sealed tender envelopes were examined by the committee and were found to be properly sealed and marked as per the tender requirements. Thereafter, the committee proceeded to open the envelopes containing the technical bids one by one.


1. M/s. R & A Hygiene Food Masters

3. M/s. Rana General Store
4. M/s. A.J Enterprises
5. M/s. Tehzeeb by ANH Diagnostics
6. M/s. Hardev Singh, Civil Hospital Canteen Palampur

After opening the bids, the committee undertook a detailed scrutiny and evaluation of the technical documents submitted by each bidder. The evaluation was carried out strictly in accordance with the eligibility criteria and conditions specified in the tender document.

During the scrutiny process, it was observed that out of the total Six bidders Five bidders fulfilled the required eligibility criteria and submitted all necessary documents in proper form as stipulated in the tender notice. The remaining one bidder named M/s. S.R Enterprises were found technically non responsive due to deficiencies in the submitted documents and non fulfillment of certain mandatory eligibility conditions consequently, this one bid were not consider for further evaluation.

After detailed examination and discussion the committee unanimously declared five bidders mentioned below technically qualified for next stage of the tender process

1. M/s. R & A Hygiene Food Masters
2. M/s. Rana General Store
3. M/s. A.J Enterprises
4. M/s. Tehzeeb by ANH Diagnostics




5. M/s. Hardev Singh (Civil Hospital Canteen Palampur)
